the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Wade Cothran, All that certain piece, parcel or lot of land situated, lying and being in Ward Two of the City of Greenville, State and County aforesaid, and being more particularly described as follows: Beginning at an iron pin on the north side of Pettigree Street, joint corner of lots four and five and running thence N. 15.00 W. along joint line of said two lots 126 feet 1 inch to an iron pin on a ten foot alley; thence along said alley N. 76.45 E. 66 feet 8 inches to an iron pin, joint corner of lots five and six; thence S. 15.00 E. along joint line of lots five and six 126 feet 1 inch to an iron pin on Pettigree Street; thence S. 76.45 W. along Pettigree Street 66 feet and 8 inches to an iron pin, the beginning corner, and known as lot five, Block Four of Boyce Lawn Addition as per plat of J. J. Lawrence, recorded in the R. M. C. Office for Greenville County, April 2, 1908, in Plat Book A at Page 179. This is the same lot, a three-fourths interest in which was conveyed to me, the said Lucy Poe Sparkman, by Harriet Joe Cogan well, Gaidete Poe Brawley and Francis Hunsdale Poe by their deed dated January 25, 1927, and recorded in the R. M. C. Office for Greenville County in Vol. 117 at page 261, the remaining one-fourth interest in said lot having been devised to me by F. W. Poe by the fifth item of his will which is recorded in the Probate Office for Greenville County. This conveyance is made subject however to the conditions and restrictions set forth in the deed from J. F. Hunt, Trustee, to Lorette M. Smith, recorded in the R. M. C. Office for Greenville County in Vol. 3 at Page 20.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said

Wade Cothran, and his heirs and assigns, forever.

AND myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

Wade Cothran and his heirs and assigns, against

me my heirs, and against every person whomsoever lawfully claiming, or to claim the same, or any part thereof.
