Paulson, deceased, on the north side of said West Stone Avenue, which point is 207 1/2 feet, more or less, from the Northwest corner of the intersection of West Stone Avenue and Hutton Street, and running thence in a southerly direction with said West Stone Avenue and parallel with Hutton Street, 200 feet in a line; thence in a southerly direction in a line parallel with West Stone Avenue 75 feet to a right corner of lot owned by Savenport Estate; thence in a southerly direction with said West Stone Avenue and parallel with Hutton Street, 200 feet to West Stone Avenue; thence in a westerly direction with the line of West Stone Avenue 75 feet to the beginning of the same.
