To W. M. Howard in hand paid  
at and before the sealing of these presents by Nathaniel J. B. Murray

The receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Nathaniel J. B. Murray all that certain piece, parcel or lot of land situated being a corner lying in the City of Greenville, at the off Stock Building, County of Greenville on the North side of the street 15 feet or so, being known and designated as Lot No. 2 Acre of the property of C. H. Tally and W. M. Howard, the same plot of said property made by Salters & Meeks, Surveyors, ready October, 1927, and record in the Office of the R. M. C. for Greenville County, in Plat Book "A" at page 162, and having, according to said plat, the following boundaries, back roads, to wit:- Beginning at a iron pin on the North end of the street, at a point 120 feet from the Northeast corner of the said close street, and running back along the North side of the street, 100 ft. 06 ft. to an iron pin; thence N. 18-00 E. 36 feet to an iron pin; thence S. 72-10 W. 50 feet to an iron pin at a point 120 feet from the back side of close street; thence S. 72-06 E. 120 feet to the beginning corner, being the same lot of land conveyed to me by C. H. Tally by deed dated August 19th, 1928, and recorded in the R. M. C. Office for Greenville County, in Volume 124, page 109.

As part of the consideration for their deed the grantees assume and agree to pay the balance due on the mortgage to the Mechanics Building & Land Association.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Nathaniel J. B. Murray, his heirs and assigns, forever.

AND I, Nathaniel J. B. Murray do hereby bind

heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Nathaniel J. B. Murray,

and myself, my self, partly, heirs and assigns, against every self partly, and, and against every person whomsoever lawfully claiming, or to claim the same, or any part thereof.
