the County where I am hereby acknowledged, have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said South Carolina Savings Bank, Receiver for Peoples Bank, Furtain, its successors or assigns, all that Certain Land, tract or lot of land, situate, lying and being in the state of South Carolina, and County and Township of Greenville, in a section about 3 1/2 miles Northwest of Greenville, bounded, known as said tract, and being known as "lot number of Section "B", according to a Plat of Greenville, made by W. A. Adams, Surveyor, and recorded in the Books "A", at page 396 and 397, and being the portion of tracts and lots, to wit: lying along at the East side of Bailey Street, extending from the intersection of Grey Avenue and said street with lot 60, and running thence South 79° East 145 feet to a pin on a stone foot Alley; thence with said Alley 8 1/2 C. 50 feet to a Pin; first corner with lot no. 62 above 71. 59 1/2 W. 200 ft line of lot no. 62, 145 feet to a Pin on Bailey Street; thence with said Bailey Street N. 17 1/2 W. to point to the beginning corner.
