Office for Greenville County, and this deed is made to correct said error in reference to the Plat Book page and also to remedy other minor irregularities

to me in hand paid at and before the sealing of these presents by Dr. John R. Harrison and Lucy Poole Harrison

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold, and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Dr. John R. Harrison and Lucy Poole Harrison,

All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, in the City of Greer and fronting on Cunningham Avenue and Spring Street, and more particularly described on a plat of the real estate of Leila W. Cunningham, prepared by W. A. Christopher September, 1921, and recorded in Plat Book F, at page 17, R.M.C. Office for Greenville County, as Lots nos 24 and 25, and having the following corners and distances to-wit:

Beginning on Cunningham Avenue at an iron pin, at the joint corner of Lots nos 23 and 24, and running thence N. 27° 0' E. 75 feet to joint corner of lots nos 23 and 25; thence N. 76° 24' 109.13 feet to an iron pin on Spring Street; thence N. 25° 45' E. 75 feet to an iron pin, joint corner of Lots 25 and 26; thence S. 70° E. 193 feet to the joint corner of Lots nos 24 and 26; thence S. 27° 30' W. 150 feet to an iron pin on Cunningham Avenue; thence N. 70° W. 80 feet to the beginning corner, reference to said Plat being craved as often as necessary.

Lot no 25 was conveyed the grantor, by Leila W. Cunningham by deed dated October 7, 1926 recorded in Deed Book 86, page 195, R.M.C. Office for Greenville County, and Lot no 24 was conveyed the grantor by Leila W. Cunningham by deed dated October 22, 1926, recorded in Deed Book 119, page 335, R.M.C. Office for Greenville County.
