Quit Claim Deed

Whereas, on August 26, 1921 William G. Sissine conveyed a certain tract of land fronting 75 feet on Ebaugh Avenue to J. B. Parker, and whereas, the meter and bounds contained in the description were correct, the tract was incorrectly described as embracing the southern portion of Lot no 121 and the Eastern one-half of the southern portion of Lot no 122.

And whereas, the tract should have been described as embracing the Western half of the southern portion of Lot no 121 and all of the southern portion of Lot no 122.

Now therefore, in order to clear up this inaccuracy the deed is given

to me and Trust Company in hand paid at and before the sealing of these presents by Carolina Loan and Trust Company

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold, and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Carolina Loan and Trust Company

All that tract or parcel of land situate in the County of Greenville, State of South Carolina, and described as follows:

Beginning at a stake on the North side of Ebaugh Avenue at the corner of lot sold to R. V. Mace and running thence with Mace's line in a Northeasterly direction 140 feet to a stake; thence parallel with Ebaugh Avenue N. 55 W. 75 feet to a stake; thence in a Southwesterly direction parallel to the first line 140 feet to a stake on Ebaugh Avenue; thence with Ebaugh Avenue S. 55 E. 75 feet to the beginning corner, embracing Western half of the Southern portion of Lot No. 121 and all of the Southern portion of Lot No. 122, as shown on a plat made by W. A. Adams, July 1909, recorded in Book "A", page 383, R. L. C. Office for Greenville County.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Carolina Loan and Trust Company, its successors, heirs and assigns, forever.

AND I myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Carolina Loan and Trust Company, its successors, heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
