TO ALL WHOM THESE PRESENTS SHALL COME:

Master in and for the County aforesaid, SEND GREETING:

WHEREAS,

on or about the 1st day of December in the year of our Lord nineteen hundred and 1903, exhibited by the complaint in the Court of Common Pleas, for the County aforesaid, against

Henry Ross, Harry Ross, Dorothy Ross and Katherine Ross

demanding relief as to the real estate described in the complaint; and the cause being at issue, came on to be heard on the 14th day of March 1903, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was

adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Lussan Master in and for the County aforesaid, to Harry Ross, Dorothy Ross and Katherine Ross for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. )

NOW, Therefore, Know all Men by these Presents, that I, E. Lussan

Master in and for the County of Greenville aforesaid, by virtue of the aforesaid decree,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Harry Ross

Katherine Ross and Katherine Ross, their heirs and assigns forever, the following described real estate: in that certain piece, parcel or tract of land, being being and situated in Greenville County, State of South Carolina, and beginning at an iron pin in place of S. H. Bell, deceased, and running thence S. 81° 15' E. 19.5 to iron pin; thence N. 66° 15' E. 7.00 to stone in line of said Ross; thence N. 72° E. 1.00 to iron pin in corner; thence S. 89° 34' E. 7.34 to S. 2.10; thence S. 81° 15' E. 3.10; thence along said branch N. 78° 12' E. 3.10; thence along said branch N. 68° E. 2.10; thence along said branch N. 27° 12' E. 7.37 to Kelly Ross; thence along said branch N. 27° 12' E. 7.37 to a point where branch of road meets said river; thence along said branch, crossing said Bear Falls Road, to the beginning corner, containing 7.65 acres, more or less.

Also, all that other piece, parcel or tract of land, being and situated in Greenville County, State of South Carolina; beginning at stone at corner of lands of H. Sullivan and J. P. Nesbitt; and runs thence N. 11° 15' E. 27.00 to P. O.; thence N. 84° E. 4.94 to stone; thence N. 90° 34' E. 6.00 to stone; thence N. 74° W. 16.65 to pine; thence N. 89° 24' E. 8.3 to stone; thence S. 17° 1/2 W. 21.00 to stone; thence S. 59° 1/2 W. 4.00 to pine; thence N. 51° 1/2 W. 9.00 to stone; thence S. 56° 3/4 W. 16.20 to stone; thence S. 51° E. 14.62 to stone; thence S. 56° 1/4 E. 6.17 to P. O. X 3; thence crossing branch S. 19° 1/2 E. 16.27 to stone, the beginning corner, and containing 66-20/100 acres, more or less, as represented upon a plat was filed, Surveyor, dated March 13, 1903.

The above lands were assigned to the present heirs by the Commissioners in partition of the estate of the late Dr. H. B. Ross and their shares in said estate were valued at \$7800.00, the tract of land first above described being represented by plat in the subdivision of said estate by J. M. Ross, Surveyor, and was represented by plat 3, and the other tract herein above described being represented by plat 2, made by J. M. Ross, Surveyor, dated March 13, 1903.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining, and all the estate, right, title, claim and interest whatsoever of the parties to the cause aforesaid, and of each of them in and to the same, and of all other persons rightfully claiming from, under, or any of them. TO HAVE AND TO HOLD, all and singular the premises before mentioned, unto the said Harry Ross, Dorothy Ross and Katherine Ross and their heirs and assigns forever.
