Bothran and her heirs and assigns, forever, the
following described real estate:
"All that certain Piece, Parcel or lot of land, situate,
lying and being in the City of Greenville, State and
County aforesaid, on the corner of Boyce and Webster
Streets and described as follows: Beginning at a Point
at the Southeast corner of Boyce and Webster Streets
and running thence in a Southern direction 100 feet
along Boyce Street to a Point on Mrs. Fannie Hatcher's
line thence in an easterly direction along Mrs. Hatcher's
line 134 feet to Katherine Brocker's lot; thence in a
Northerly direction along the Katherine Brocker's line
100 feet to Webster Street; thence in a Westerly direction
with Webster Street 134 feet to the beginning corner."
