Master in and for the County aforesaid, SEND GREETING:

WHEREAS, H. E. Jordan, et al

on or about the 24th day of December in the year of our Lord nineteen hundred and twenty-eight their complaint in the Court of Common Pleas, for the County aforesaid, against

J. S. Jordan

demanding relief as to the real estate described in the complaint; and the cause being at issue, came on to be heard on the 19th day of January 1929, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Inman

Master in and for the County aforesaid, to Nora Jordan for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No.)

NOW, Therefore, Know all Men by these Presents, that I, E. Inman, Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and by these presents, DO GRANT, convey and release unto the said Nora Jordan,

her, heirs and assigns forever, the following described real estate: All that certain piece, parcel or tract of land situate, lying and being in Greenville County and partly in Laurens County, in the State aforesaid, containing 1.05 acres, more or less, and being described by metes and bounds as follows: Beginning at a corner in old road, thence along said road S. 56 21. 3.26 to angle; thence S. 63 21. 5.86 to stake in said road; thence S. 78 18 21. 14.65 to stake on the old line bounded by J. L. Traynham at that time; thence S. 58 31. 52 to stake on bank of Horse Creek; thence down the meanderings of said creek to the bridge corner in said creek; under the bridge; thence along the road S. 66 1/2 E. 2.00 to angle; thence N. 73 E. 1.28 to angle; thence N. 79 E. 2.72 angle; S. 89 1/2 E. 3.00 angle; thence N. 67 E. 2.50 angle; S. 75 E. 4.50 angle; N. 84 E. 1.50 angle; N. 56 E. 2.25 angle; N. 20 E. 1.00 corner in said road which is N. 54 21. 51 links from white oak stump; thence S. 11 1/4 E. 2.3 1/2 stake; thence S. 5 21. 24. 34 stake on the northeast bank of said creek; bounded by tract No 3, now owned by J. L. Traynham thence down the meanderings of said creek about 13 1/2 chs to stake; thence N. 11 1/2 E. 4.61 Red Elm on east bank of branch; thence with said branch about 38.50 to a poplar on the east bank; thence N. 31 E. 2.90 to side of branch; bounded from the creek by tract No 4; thence N. 23 21. 4.11 to a corner in the spring; thence N. 12 21. sweet gum

on the east side of the road; thence along this old road N. 57 7/8 E. 3.56 stake; thence S. 88 21. 10.15 to a corner in the road; thence N. 7 1/4 E. 4.15 to the beginning corner, which is N. 45 1/4 E. 6.9 from a large Post oak.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining, and all the estate, right, title, claim and interest whatsoever of the parties to the cause aforesaid, and of each of them in and to the same, and of all other persons right-fully claiming from, under, or any of them.

TO HAVE AND TO HOLD, all and singular the premises before mentioned, unto the said Nora Jordan, her heirs and assigns forever.
