TO ALL WHOM THESE PRESENTS SHALL COME:

I, E. J. Juman
Master in and for the County aforesaid, SEND GREETING:

WHEREAS, B. B. Henson and Annie May Fisher

on or about the 8th day of July in the year of
our Lord nineteen hundred and thirty exhibited this complaint in the Court
of Common Pleas, for the County aforesaid, against Hyda Pearl Henson, et al.

Demanding relief as to the real estate described in the complaint; and the cause being at issue, came on to be heard on the 18th
day of July 1930, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was
adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Juman
Master in and for the County aforesaid, to Annie May Fisher
for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. _____)

NOW, Therefore, Know all Men by these Presents, that I, E. Juman
Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree,
HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

Annie May Fisher, the following described real estate:

"All that certain tract of land, in Highland
Township, Greenville County, State of South Carolina
and on the south side of a highway, containing
50 acres and having the following limits and bounds
and courses and distances, as shown by a survey
and plat, made by J. H. Atkins, Surveyor, April 26
1928, to-wit:

Beginning at an iron pin at the northwest
corner of Church lot and in center of highway and
running thence along the line of the Church lot
S. 15^o E. 374 feet to a stone; thence continuing along
the line of the Church lot S. 82^o 45' E. 420 1/2 feet to a
stake; thence continuing along line of said Church
lot N. 17^o E. 210 feet to a pine in bar near road; thence
continuing along the line of said Church lot and
along the line of said highway N. 30^o 20' W. 280 1/2 feet to
a pin in center of said highway; thence along the
line of Lillian Thomas's land S. 74^o 15' E. 1234 feet to
a stake; thence S. 1^o 52' W. 1111 feet to a stone; thence
N. 87^o 38' W. 1258 feet to a stone; thence N. 25^o 25'
W. 1444.7 feet to pin; thence N. 33^o 3/4' E. 203 feet to a
pin in highway; thence along the center of said
highway N. 82^o 20' E. 211 feet to pin at the beginning
corner.

The above land was devised to the grantee
herein under items 3 of the Will of her father,
W. J. Henson.

TO HAVE AND TO HOLD, all and singular the premises before mentioned, unto the said
Annie May Fisher, her heirs and assigns forever.
