KNOW ALL MEN BY THESE PRESENTS, That Woodside Cotton Mills Company,

a corporation chartered under the laws of the State of South Carolina, and having its principal place of business at Greenville in the State of South Carolina, for and in consideration of the sum of One Dollar (\$1.00)

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

The Temple Baptist Church, of Simpsonville, S. C. for Church purposes:-

All that certain piece, parcel or lot of land situate, lying and being in Simpsonville, State and County aforesaid, on which is located the Church building of The Temple Baptist Church, and being more particularly described as follows, as shown by plat made by Dalton & Neves, September, 1937.

Beginning at an iron pin on the West side of Church Street, joint corner of property of Woodside Cotton Mills Company and running thence along Church Street N. 25-30 W. 130 feet to an iron pin on the South side of First Street, and running thence along First Street S. 64-30 W. 94.5 feet to an iron pin, corner of property of Woodside Cotton Mills Company; thence along line of property of said company S. 25-30 E. 130 feet to an iron pin; thence still along line of property of Woodside Cotton Mills Company, N. 64-30 E. 94.5 feet to an iron pin, the beginning corner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinafter named, and its successors

so long as the said property shall be used for church purposes and when no longer so used the same shall revert to the Grantor herein, its successors and assigns.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinafter named, and its successors

and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
