Timber now standing to be cut into wagon lengths and left on ground.

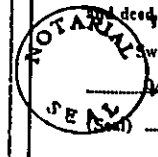

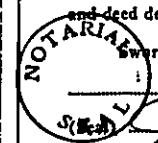
