All that certain lot of land situate near the City of Greenville, County and State aforesaid, on the Eastern side of Jones Avenue, and being a portion of Lot No. 8 and 9, as shown on a plat for the property of H. L. McDaniel recorded in the R. M. C. Office for Greenville County in Plat Book F, page 1816 and having, according to a plat prepared by C. M. Furman Jr. May 14, 1928, the following metes and bounds, courses and distances, etc. -

Beginning at an iron pin on the eastern side of Jones Avenue, which pin is 20 feet South of the southern line of lot No. 8 as shown on said plat, and running thence along the eastern side of Jones Avenue, N.W. 1-00 E. 50 feet to an iron pin, which pin is 40 feet south of the southern line of lot No. 7 on said plat; thence S. 89-00 E. 230 feet to an iron pin; thence S. 5-08 E. 50.1 feet to an iron pin; thence N. 89-00 E. 226.5 feet to the point of beginning, being a part of the property conveyed by A. H. Christian to A. H. Reynolds, by deed dated April 19, 1928, and recorded in the R. M. C. Office for Greenville County, in Volume 143, page 199, it. v. Reynolds having split subsequently conveyed by deed unto the other grantees herein a two thirds interest, so that each of the said grantees herein is vested with a one-third undivided interest in said property.
