W. L. Cleveland,

All the L-edges, parcels or tract of land, situate, lying and being in Greenville County, in the said County, which contains, containing, 6.53 acres, more or less, has been surveyed and made, by R. E. Dalton, Engineer, January 1933, and described as follows:

Bounding at a stone, joint corner between properties of the grantor and grantee herein, said stone being the southeast corner of property of the grantor, the first along joint line between said properties, N. 4-27-6. 915 feet from iron pin on bank of branch, thence down the branch with the meanders of same, to the intersection with a second branch, thence along the meanders of second branch to an iron pipe on bank of same and on joint line between said grantor and grantee, a traverse line between said points being as follows: S. 43-10 W. 200 feet to a bend, L. D. 55. 40 S. 195 feet to a bend, S. 0-20 W. 164 feet to a bend, S. 20-8 W. 158 feet to a bend, L. D. 55 W. 265.5 feet (iron pipe), thence along said joint line, S. 88-33 E. 495 feet to the point of beginning.

L-edges with the right of the grantee for heirs and assigns, to use for common with the grantor, his heirs and assigns, in perpetuity, the two springs located just above the branch above mentioned on the property of the grantor, with the right of ingress and egress to said springs.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *W. L. Cleveland*, his
