the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said

L.B. Long, "All that certain parcel and lot of land situate and being in the State of South Carolina, Greenville County, Highland Township, having the following metes and bounds: Beginning at a stake in the center of the Highland-O'Neal Road, at the intersection of Camp Creek Road and running thence with the center of the Camp Creek Road as the line 12.50 chs. to a stake in the center of the road, intersection of the line of Moon Lands; thence N. 70 E. 24.60 chs. to a stone on the Belcher Land; thence N. 24 E. 31.80 chs. to stake; thence S. 25 E. 5.54 to stake; thence S. 36 E. 4.64 to stake; thence S. 39-1/2 E. 5.90 to stake in center of the O'Neal Road; thence with the said road S. 37-30 E. 12.54 chs. to the point and place of beginning, and being designated as Lot No. 3 on a plat prepared by W.P.
