Mrs. Corrie Greer, the following described real estate:

"All that certain piece, parcel or tract of land, situated, and being in Chick
Springs Township, Greenville County, State of South Carolina, containing 29.30 acres,
more or less, and bounded by the lands of Rescoe Green on the North, Will Johnson on
the East, Enoree River on the South and J. M. Weed on the West, and being more completely
