TITLE TO REAL ESTATE

in the City of Greenville, on the east side of Watson Street, described as follows:

Beginning at an iron pin on the east line of Watson Street at a point 204 feet from Grace Street and running thence in a southerly direction with Watson Street 51 feet to an iron pin; thence in an easterly direction with line of lot #14 114 feet to an iron pin at a wooden fence; thence in a northerly direction parallel with Watson street 51 feet along fence to an iron pin; thence in a westerly direction with line of lot #12 to the beginning corner.
