(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Daisy B. Cleveland, her heirs and assigns:  
All that certain piece, parcel, or tract of land  
situate, lying and being in South Township,  
County of Greenville, State of South Carolina,  
and more particularly described as follows:  
Beginning at a stone on the East bank of  
Old Golden Grove Creek, about five chains below  
the junction of the middle and east forks of  
the said creek, and running thence S. 86° E.  
17.50 to a dog-wood, thence S. 24 1/2° E. 20.07 to a  
stone in old road bed, thence N. 86 1/2° E. 8.25  
to a stone in road to Reedy River Factory,  
thence N. 13 1/2° E. 17.50 to Hickory, thence N. 44° E.  
crossing the East Fork of Golden Grove Creek  
41.24 to a stone, thence S. 85 1/2° E. 12.39 to an iron  
wood tree on the East Fork of said Golden Grove  
Creek, thence up the said fork in a northerly  
direction following the median of the same,  
19.30 to a willow at the mouth of a branch,  
thence with said branch in a northwesterly di-  
rection 17.10 to a black gum, thence N. 85 1/2° E.  
10.94 to a stone, thence S. 43.15° E. 41.80 to stone
