B. Jordan and lands of H. E. Chandler and

Name of Place, which I (or we) may own in whole or in part, for the purpose of constructing and maintaining said highway, with the bridges and causeways thereon.

A part of the consideration of this deed, being that the State Highway Commission is to move the store house belonging to the grantor from its present location to a point to be agreed upon not over one hundred yards from its present location.
