

at the request of the Trustees under said will or their successors, convey, assign and transfer the said Property to them, or their Order, free and discharged of any Trust hereunder.

Provided that said Church or Society herein before described shall have the privilege of repaying the said Trustees under the will of Mary Baker Eddy the amount of the Grant on which this trust instrument is based, and upon repayment thereof, may receive a discharge of all liens and liabilities hereunder.

The expression "the said Trustees and/or their successors" shall be held to apply to the Trustees under the will of Mary Baker Eddy for the time being whether herein named or hereafter appointed to fill a vacancy now existing or hereafter created.
