T. Burnett, J. C. James and others and upon, along and over under the roads, streets or highways adjoining the said property, with the right to trim grass ^{from} ^{the} ^{lines} ^{along} ^{said} ^{lines} ^{so} ^{as} ^{to} ^{keep} ^{the} ^{wires} ^{and} ^{cables} ^{clear} ^{at} ^{least} ^{thirty} ^{six} ^{inches} ^{and} ^{the} ^{right} ^{to} ^{permit} ^{the} ^{attach-} ^{ment} ^{of} ^{and} ^{for} ^{any} ^{or} ^{conduit} ^{wires} ^{and} ^{cables} ^{of} ^{any} ^{other} ^{company} ^{and} ^{with} ^{the} ^{fur-} ^{ther} ^{right} ^{to} ^{cut} ^{down} ^{all} ^{trees} ^{and} ^{under-} ^{growth} ^{within} ⁵⁰ ^{feet} ^{of} ^{said} ^{line} ^{the} ^{grantor} ^{for} ^{himself} ^{his} ^{heirs} ^{executors} ^{administrators} ^{and} ^{assigns} ^{hereby} ^{covenants} ^{that} ^{no} ^{wire} ^{line} ^{will} ^{be} ^{erected} ^{or} ^{permitted} ^{on} ^{said} ^{property} ^{which} ⁱⁿ ^{the} ^{judgment} ^{of} ^{the} ^{grantor} ^{its} ^{successors} ^{and} ^{assigns} ^{will} ^{interfere} ^{with} ^{its} ^{service} ^{or} ^{endanger} ^{its} ^{lines} ^{and} ^{that} ^{no} ^{inflammable} ^{structure} ^{will} ^{be} ^{erected} ^{or} ^{permitted} ^{on} ^{said} ^{property} ^{within} ⁵⁰ ^{feet} ^{of} ^{said} ^{lines} ^{said} ^{sum} ^{being} ^{received} ⁱⁿ ^{full} ^{payment} ^{for} ^{the} ^{rights} ^{herein} ^{granted} ^{and} ⁱⁿ ^{full} ^{payment} ^{for} ^{all} ^{wood} ^{and} ^{timber} ^{damage}.
