A right of way sufficiently wide to construct the road as planned and not less than 15 feet wide, on each side of center line of road, on and over all lands lying along the road, known as Fork Shoals Road, at any point or points lying between Sta. 10+0 and Sta. 20+70 <sup>name of place</sup> which I (or we) may own in whole or in part, for the purpose of constructing and maintaining said highway with the bridges and causeways thereon, with cuts sloping of banks 1 to 1 and fills to be sloped 1 1/2 to 1.

Together with, all and singular, the rights, tenements, hereditaments and appurtenances thereto belonging, or in anywise incident or appertaining. It is agreed that any buildings or fences to be moved from the right of way will be moved at the expense of said County or State.

To Have And To Hold, all and singular, the said right of way and the rights hereinbefore granted, unto the said Greenville County Highway Commission, its successors and assigns, so long as the same shall be used as part of the highway system of this County, State or Nation.
