All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, lying in the City of Greenville and being lots nos 1, 2, and 3 on plat of the same, made by B. E. Dalton, December, 1912, and having the following metes and bounds, to wit:

Beginning on an iron spike on the northeast side of an unnamed Street, corner of Tom Davis and running thence with said street N. 41 E. 182 feet to an iron spike, corner of Tom Davis; thence with line of Tom Davis N. 78-15 21. 63. 1 feet to a branch; thence with said branch following the meanderings approximately S. 56. 0 30. 24. 140. 4 feet, more or less; thence S. 50-07 E. 95. 7 feet to the beginning corner, and being the same land formerly deeded to me by Joe Williams March 26 1929, and recorded in Vol 148 at page 292.
