as follows: Beginning at a point on said
Anderson Street 2.5 feet south of an alley
and running thence S. 68.15 E. 12.5 feet thence
S. 23.34. 41 feet; thence N. 67 1/2 W. 12.5 feet to
Anderson Street; thence along said street N.
22 E. 41 feet to the beginning corner.

Also all that other lot of land in the
City of Greenville, State and County aforesaid,
adjoining above described lot, and
described as follows: Beginning at the corner
of the above lot on Anderson Street, at a
point 66 feet from the above alley, and
