in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said E. E. Odum, and his heirs and assigns

all that piece, parcel or lot of land in Highland Township, Greenville County, State of South Carolina. To wit:

Beginning at stone on corner of A. Roman and E. H. Davis land, thence south following line of E. H. Davis and A. Roman to bed of creek joining E. H. Davis; thence up the center of creek to maple tree and corner on Mrs. Lizzie Caldwell and E. H. Davis line; thence follow line in north west direction of Mrs. Lizzie Caldwell and E. H. Davis to stone at corner of A. Roman and others; thence follow A. Roman line back to beginning corner, and being a part of the land that I received from B. J. Odum.

Also all that certain piece, parcel or lot of land situate, lying and being in Highland Township, County of Greenville, State of South Carolina, according to survey of J. St. Atkins, surveyor, Nov. 1st, 1929, and described as follows:

Beginning on a stone at E. H. Davis and Mourad Dills corner and runs thence N. 35.37 E. 27.3 ft to an iron pin in the Tiger Hill Road thence with said Tiger Hill Road S. 45.50 E. 157 ft to an iron pin; thence S. 35.37 W. 296 feet to an iron pin in old road; thence N. 37.12 W. 157 1/2 feet to the beginning corner and bounded by lands of E.
