"All that lot, piece, or parcel of land in the County of Greenville, State of South Carolina, known and designated as Lot No. 1041 of Plat No. 3, of the property of the Tryon Development Company, known as Lake Lanier, made by Wm. Kenney, C.E., and duly recorded in the office of R. M. G. for said County in Plat Book - Page 1."
