WHEREAS Lewis Harker and Investment Company,

a Corporation, as trustee

on or about the 22 day of July in the year of our Lord nineteen hundred and twenty-eight exhibited its complaint in the Court of Common Pleas for the County aforesaid, against Wm. Hester Umbach, et al.

NOW, therefore, Know all Men by these Presents, That I, C. J. Jones Master in and for the County of Greenville, aforesaid, in consideration of the sum of Thirty-five Hundred (\$350.00) Dollars, to me paid by the said Lewis Harker

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said

Lewis Harker, the following described real estate: All that piece, parcel or plot of land situated, lying and being just outside of the corporate limits of the City of Greenville, County of Greenville, State of South Carolina, and being known and designated as Lot 22 on a plat of the property of Mrs. J. C. Lewis, recorded in R.M. & Office for Greenville County, in Plat Book 7 at Page 135, and having, according to a plat thereof prepared by S.H. Millard, Engineer, August, 1926, the following metes and bounds, to-wit:

Beginning at a raw iron pipe on the backside of Bonnetts Avenue which said pipe is 100 feet North of the intersection of Bonnetts Avenue and Olive Street, and running thence along said Bonnetts Avenue, N. 27-10-00 feet to a raw iron pin; thence S. 62-50-00 feet to a raw iron pin; thence N. 27-10-00 feet to a raw iron pin; thence N. 62-50-00 feet to the point of beginning.
