lying and being in the State of South Carolina, and
County of Greenville, State aforesaid, about 15 miles
northwest from Greenville Court House, and having
the following metes and bounds, to-wit: Beginning
at a post, and running thence S 82° E. 10.52 to a stone,
thence N 68° E. 11.44 to a stake in the road; thence N
88° W. 9.52 to a stake in road; thence S 72° W. 11.40 to the
beginning corner, and containing 16.83/100 acres, more
or less.

Also: All that other piece, parcel or tract of land adjoining
the above described tract, situate, lying and being in
the State, County, and Township aforesaid, and having
the following metes and bounds, to-wit: Beginning at
