the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said Mrs. Addie Jones, the following described real estate:

"All that certain piece, parcel or lot of land situate, lying and being in the County and State aforesaid, and having the following metes and bounds, to wit: Beginning at an iron pin on the National Highway, and running thence N. 67 $\frac{1}{2}$ E. 4.43 chs. to corner of Lot No. 6; thence along the line of Lot No. 6, N. 8 W. 3.16 chs. to the corner of Lot No. 3; thence along the line of this lot, S. 67 $\frac{1}{2}$ W. 5.63 chs. to line of Lot No. 1; thence along line of lot No. 1, S. 27 E. 3.07 chs. to the beginning corner, containing one and fifty-four hundredths (1.54) acres, more or less, and designated as Lot No. 2 on a plat of S.
