all that piece, parcel or lot of land in *Gantt* Township, Greenville County, State of South Carolina.

situate lying and being on the east side of the Southern Railway between Greenville, S. C. and Piedmont S. C. and being more fully described as follows: Beginning at a point at the intersection of the Southern Railway property and a cross-country road which runs from West Gantt School house to the White Horse road and running along center of said road east to the Fuller line; thence north along the line of the Fuller property 385 feet to an iron pin; thence in a northeasterly direction 945 feet to an iron pin adjoining the Southern Railway property; thence along Southern Railway property to the beginning point same being known as tract No. 8 as shown by a plat of the C. C. Good property near Gantt Station, and containing six acres more or less.
