(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *Dimmons Realty Company*, all that piece, parcel, or tract of land, situate, lying and being in Butler Township, Greenville County, State of South Carolina, on the old Spartanburg road, sometimes known as Scuffletown road, and having the following metes and bounds, to wit:

Beginning at an iron pin in the edge of Scuffle-Town road, Ruffiss corner, and running thence N. 25 1/4 E. 6.17 to an iron pin, thence N. 44 1/2 E. 6.00 to an iron pin, thence N. 44 1/2 W. 13.64 to an iron pin, thence S. 44 1/2 W. 11.00 to an iron pin at ditch, thence S. 27 1/2 E. 11.4 to an iron pin at post, thence S. 3 X W. 2.803 to an iron pin in the edge of Scuffletown road, thence along said road S. 81 1/2 E. 5.27 to the point of beginning, and containing 18 acres more or less.
