the receipt whereof is hereby acknowledged have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
Miss Sarah Little, her heirs and assigns forever.

All the undivided interest, being all her interest, in the following described
three parcels of land, or lots on the south side of Mountain View Avenue, in the County
of Greenville, State of South Carolina.

1st--Beginning at a stake on the South side of Mountain View Avenue and running
thence along said Avenue N. 79 45 W. 100 feet to a pin; thence S. 10 15 W. 170 feet
6 inches to a pin; thence E. 79 45 E. 100 feet; to a pin; thence N. 15 E. 170 feet 6
inches to beginning corner and being further described as lot no. 7 of a plat of sub-
division of Buist property, known as Oakland Heights, made by W. D. Neaves, June 1st,
1911. Said lot being the same conveyed to Misses Maggie, Sarah and Ella Little, by
W. C. Wharton Sept. 8, 1913, and recorded Vol. 23, page III R.M.C. Greenville County.

2nd--Beginning at a stake corner lots Nos. 5 and 6 on Mountain View Avenue,
thence with Mountain View Avenue in an easterly direction 100 feet to a stake at corner
lots 6 & 7; thence with dividing line of lots 6 and 7 in a southerly direction 170 feet
6 inches to a stake on 19 feet alley; thence with said alley in a westernly direction
100 feet to a stake in said alley and joint corner of lots 5 and 6; thence with dividing
line of lots 5 and 6 in a Northernly direction 170 feet 6 inches to the beginning corner
on Mountain View avenue and known as lot No. 6 of Subdivision of Buist property known
as Oakland Heights according to plat made by W. D. Neaves, surveyor. Being same lot con-
veyed to Misses Maggie, Sarah and Ella Little by H. P. McGee Sept. 10 1913, and recorded
in Vol. 23, page 109 P. M. C. Greenville County.

3rd--Beginning at a stake 335 feet from corner of Robinson Street and Moun'
View Avenue; thence with Mountain View Avenue in an Easternly direction 100 feet to
corner of lots 5 and 6; thence with dividing line of lots 5 and 6 in a Southernly dir-
ection 170 feet 6 inches to a stake in 19 feet alley; thence with said alley in a west-
ernly direction 100 feet to a stake corner of lots 4 and 5; on said alley; thence with
dividing line of lots 4 and 5 in a Northernly direction 170 feet 6 inches to the begin-
ning corner and being lot No. 5 of Subdivision of Buist property known as Oakland Heights,
said lot being lot conveyed ~~to~~ by W. C. Wharton to Misses Sarah and Ella Little by deed
dated Sept. 8th, 1913 and recorded in Vol. 123, page 110 R. M. C. for Greenville
County.
