thence S. 86-42 W. 50 feet to an iron pin on western line of lot No. 22; thence S.
11-18 E. 50 feet to an iron pin on ten foot alley; thence with said ten foot alley,
N. 86-42 E. 50 feet to an iron pin to southwest corner of lot No. 25; thence N. 11-18
