Olive J. Goring, his heirs and assigns forever:

all that certain lot of land situate, lying and being in the County of Greenville, and State of South Carolina and being known and designated as lot no. 1 of plat of property of Wade Cochran, which plat is recorded in the office of the R.M.C. for Greenville County in Plat Book "H" at page 163, and having the following meter and boundary Beginning at an iron on the east side of McDaniell Avenue 82.5 feet from the northeast corner of McDaniell Avenue and Warner Street, running thence S. 81.15 E. 170 feet to an iron pin on line of lot no. 39, thence N. 9.35 E. 82.5 feet to an iron pin, joint corner of lots 1 and 39, thence N. 81.15 W. 170 feet to an iron pin on McDaniell Avenue, thence with McDaniell Avenue S. 9.35 W. 82.5 feet to the point of beginning.
