the aforesaid lot or parcel of land in the County and State aforesaid, lying south of the corporate limits of the City of Greenville and bounded as follows and designated as lot No. 21 of May B. Reeves property as shown on a plat recorded in office of Register of Deeds of Greenville County in Plat Book F, Page 636, said lot, containing one hundred feet fronting on one hundred and forty feet running back at uniform width a depth of 180 feet and appears by reference to said plat being one of the lots conveyed to us by W. D. Parris and J. C. Gower by Deed dated April 27th, 1930 and recorded in Vol. 183, Page 115 in office of Greenville County.
