"All that piece, Parcel or lot of land, being known
as lot no. 11 Block "D" of the Sterling Annex, said Sterling
Annex being located just beyond the limits of the City of
Greenville, South of Linkins Street and adjoining the
property formerly known as Sterling College. A plat
of said Sterling Annex is recorded in Book "H", Page #9
and transferred in Book "C" Page #81 by reference to said
plat the dimensions of lot no. 11, Block "D" will be
found as follows:

Beginning at an iron pin on the west side of Minne
Street five hundred fifty (550') feet from the north-west
corner of Minne and Valentine Streets and running
thence with Minne Street N. 47-45' East fifty (50')
feet to an iron pin; thence N. 44-50' west one hundred
