All that certain piece, parcel, or tract of land lying, being and situate in Oneal Township, Greenville County and State aforesaid, containing seventy four and sixty seven hundredths (74.67) acres, being plots of land bought by me from J. P. Vaughn, deed dated March 5th, 1900; J. T. Taylor deed dated Dec. 23rd, 1915; J. A. Vaughn, deed dated Jan. 8th, 1913; J. A. Vaughn deed dated Jan. 29th, 1907; S. W. Taylor deed dated Oct. 5th, 1910, all of which is combined into one tract and described as follows:— Beginning at pin in Apalache Road, lands of C. R. Taylor on East and lands of W. B. Vaughn on West, running with said road N. 17. E. 7.58 to pin in road; thence N. 2.5 E. 1.41 with road to pin in road; thence N. 7 1/2 E. 7.06 with road to stone in road in front of W. P. Vaughn's home; thence N. 28 1/2 E. 2.40 to stone in valley below pecan tree; thence N. 19 W. 2.88 to stone; thence N. 18 1/4 W. 3.07 to iron pin; thence N. 80 3/4 W. 7.60 to iron pin; thence N. 2 W. 6.08 to stone; W. L. Smith lands; thence S. 87 E. 3.05 to stone corner Taylor Bros. Nursery lands; then on the same course 8.73 to stone; thence S. 6 1/2 E. 15.02 to stone W. lands of W. P. Vaughn; thence N. 72 3/4 E. 7.60 to stone across stream; thence S. 15 1/4 E. .72 limbs to maple tree; thence N. 77 1/2 E. 6.20 to pine stump corner of Balue Lands; thence S. 36 1/2 E. 5.66 to stone corner of J. V. Smith lands; thence S. 22 W. 14.73 to maple corner of C. R. Taylor lands; thence S. 67 1/2 E. 4.30 to iron pin; thence S. 48 W. 5.30 to iron pin; near large rocks in field; thence S. 88 W. 6.04 to iron pin; thence S. 35 W. 7.08 to iron pin; thence S. 88.30 W. 12.83 to beginning corner in road.
