Whereas, R. B. Carter, Lucile C. Cullum and Robert M. Carter,

on or about the 24th day of March in the year of
our Lord nineteen hundred and thirty two exhibited X complaint in the
Court of Common Pleas, for the County aforesaid, against Helen V. Carter,

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 25th
day of March 19 32, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was
adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Inman,

Master in and for the County aforesaid, to Mrs. Othella C. Thornton,
for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. X)

NOW, Therefore, Know all Men by these Presents, that I, E. Inman,
Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree.

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

Mrs. Othella C. Thornton:

All the undivided right, title and interest of Helen V. Carter in and to,
all that certain piece, parcel or tract of land, lying and being situate in Greenville
County, S. C., Butler Township fronting south on the Greenville Woodruff surfaced Road,
bounded West by lands of Estate of Mrs. Bessie Miller Bailenger and Walter Green, North
by lands of said Green and lands now or formerly of Ecta Stenhouse and east by lands of
Mrs. Lucile Carter Cullum, et al., said land begins in center of said Road 12.79 chains
West of corner Mrs. Kittie Miller Albertson and runs North 26 degrees 46.10 chains, more
or less, to center of Old Rock Hill Church road, thence with said road North-60-30-East
8.00 chains; thence North-13-30 West-0.50 chains to large Stone original corner of
Watson and Miller tracts; thence South 83 West 46.75 along Stenhouse and Walter Green
lines to Rocky Creek waters; thence down said waters to center of said road, thence with
said Rock Hill Church road 25.46 chains to corner at said Greenville Woodruff Road;
thence with said highway 19.90 chains, more or less, to the beginning corner and con-
taining 100.58 acres, more or less, according to plat drawn by C. M. Furman, Surveyor,

As a part of the consideration herein above expressed the grantee herein by
accepting this deed expressly assumes and promises to pay a certain debt, note or bond
secured by a mortgage to the Federal Land Bank of Raleigh, N. C., upon which there is
now a balance of \$5531.46, payable in semi-annual installments of \$210.00 Feb. 1st,
and Aug. 1st of each year until amortized.
