All that piece, parcel or lot of land situate lying and being in Chick Springs Township, State and County aforesaid, in the town of Greer, and having the following metes and bounds to-wit:

Beginning at an iron pin on the East side of Cannon Street 113.70 feet North from an iron pin at the corner of Hill and Cannon Street, and runs thence N. 57.17 E. 139.3 feet to an iron pin; thence N. 30.53 E. 70 feet to an iron pin; thence S. 57.17 W. 139.3 feet to an iron pin; thence S. 30.53 W. 70 feet along Cannon Street to the beginning corner, being lot No. 2, and containing 9751 feet of land.
