All that piece, parcel or tract of land, situated, lying and being in the State and County aforesaid, Butler Township, adjoining the lands of the Roper Mountain Church having the following metes and bounds, to-wit:

Beginning at a point in center of road to the Greenville Airport, this being the present corner between P. A. King and Roper Mountain Church, thence N. 85-56 W. 155.0 feet to an iron pin in the center of road to Greenville Airport; thence N. 5-30 E. 243.7 feet to a stake; thence N. 26-34 E. 291.0 feet to an iron pin on north edge of Roper Mtn. Road; thence along north edge of road S. 43-35 E. 160.9 feet to a rock; thence S. 57-28 W. 272.0 feet to a rock at corner of present graveyard; thence S. 25-11 E. 277.5 feet to the point of beginning, containing One acre, more or less.
