Hammett* all that piece, parcel or lot of land in *Greenville* Township, Greenville County, State of South Carolina,

City of Greenville in subdivision known as North Hills and designated as Lot B of said subdivision, according to plat made by Dalton and Neves and recorded in Plat Book N. page 90, and having according to said plat the following metes and bounds, to wit: Beginning at a pin on north side of Elizabeth Street and running thence in a north easterly direction approximately N. 75.15 E. 45 ft. to an iron pin, joint corner of lots B and R; thence along joint line of lots N. 3.30 W. 158 ft. to an iron pin; thence N. 64.00 W. 118 ft. to an iron pin; thence S. 12.35 W. 29 ft. to an iron pin; thence S 21.30 E 216.4 ft. to the point of beginning.
