WHEREAS, G. B. Foster, C. L. Miller, and M. L. Rodgers,
all of Greenville, S. C.

did on the 23rd day of January, 1933, file with the Secretary of State a written Declaration signed by themselves, setting forth:

FIRST: That their names and residences are as above given.

SECOND: That the name of the proposed Corporation is Foster Drayage Co. Inc.

THIRD: That the principal place of business is Greenville, S. C.

FOURTH: That the general nature of the business which it is proposed to do is a general drayage, hauling and storage business; also trading in building supplies and materials; also the right to buy and sell real estate and chattel mortgages, and the right to buy, sell or trade in real estate.

FIFTH: That the amount of the capital stock is Three Thousand (\$3,000.00)

payable in property at its fair value. Dollars,

SIXTH: That the number of shares into which the capital stock is divided is thirty (30) of the par value of One Hundred (\$100.00)

SEVENTH: That, after due notice, a meeting of the subscribers was held on the 17th day of January, 1933, at which a majority of all stock in value being present in person or by proxy the following were elected directors: G. B. Foster, C. L. Miller and M. L. Rodgers,

EIGHTH: That subsequently there was elected as President G. B. Foster, as Vice-President, C. L. Miller, as Secretary, M. L. Rodgers, as Treasurer, G. B. Foster

NINTH: That all requirements of Chapter 453 Article 2 Code of Laws of South Carolina, 1932 and all amendments thereto, have been duly and fully complied with, 50 per cent. of the aggregate amount of the capital stock having been subscribed by bona fide subscribers, 20 per cent. of the capital stock subscribed having been paid to the Treasurer, and three days' public notice of the intention to file this Declaration with the Secretary of State having been given in Greenville Daily News a newspaper published in the County of Greenville

NOW, THEREFORE, I, W. P. Blackwell Secretary of State, by virtue of the authority in me vested by the aforesaid Code and Acts amendatory thereto, do hereby certify that the said Company has been fully organized according to the laws of South Carolina, under the name and for the purposes indicated in their written declaration, and that they are fully authorized to commence business under their charter; and I do hereby direct that a copy of this certificate be filed and recorded in the office of the Register of Mesne Conveyance or Clerk of Court in each county where such Corporation shall have a business office.
