P. Hamilton and C. M. Mullins, our said attorneys, or either of them, full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises as fully to all intents and purposes as we might or could be if personally present, the hereby ratifying and confirming all that the said W. P. Hamilton and C. M. Mullins, our attorneys, or either of them, shall lawfully do or cause to be done by virtue of these presents.
