17. All those rights, privileges, and easements granted to N. B. Dial and others by Serena M. Sullivan by deed dated April 8, 1907, recorded in Book 17, page 47, and by N. B. Dial and others granted to the National Utilities Company of South Carolina by deed dated March 1, 1928, recorded in Book 57, page 128.

18. All those rights, privileges, and easements granted to N. B. Dial and others by Martha Abercrombie by deed dated March 6, 1907, recorded in Book 17, page 49, and by N. B. Dial and others granted to the National Utilities Company of South Carolina by deed dated March 1, 1928, recorded in Book 57, page 128.

19. All those rights, privileges, and easements granted to the Reedy River Power Company by L. F. Simpson and M. E. Simpson by deed dated April 18, 1907, recorded in Book 17, page 57, and by the reedy River Power Company granted to the National Utilities Company of South Carolina by deed dated February 15, 1928, recorded in Book 57, page 29.

20. All those rights, privileges, and easements granted to N. B. Dial and others by J. H. Sullivan by deed dated February 27, 1907, recorded in Book 17, page 250, and by N. B. Dial and others granted to the National Utilities Company of South Carolina by deed dated March 1, 1928, recorded in Book 57, page 128.

21. That tract of land on Reedy River, bounded on the North by lands of J. H. Sullivan, on the East and South by lands of J. H. and N. M. Sullivan, and on the west by lands of the Neal Andrews Estate, N. B. Dial, and others, and known as the Long Shoals, containing 45 acres, more or less.

Also, the right, privilege, and easement to back water in and through, over, and upon other lands of N. M. and J. H. Sullivan known as the Higgin S. Garlington land below the said Long Shoals on the said Reedy River.

The said tract of land and the said right, privileges, and easement are the same which were conveyed to the Reedy River Power Company by N. M. Sullivan and J. H. Sullivan by deed dated March 8, 1907, recorded in Book 22, page 389, and by the Reedy River Power Company conveyed to the National Utilities Company of South Carolina by deed dated February 15, 1928, recorded in Book 57, page 29.

22. That tract of land containing 10-1/3 Acres, more or less, bounded on the North and East by the lands of J. H. Sullivan, Trustee for Mrs. Lizzie S. Garlington, and on the South and West by lands formerly of Reedy River Power Company, as shown by plat made by J. H. Hudgens, Surveyor, January 28, 1910; being the same tract of land conveyed to the Reedy River Power Company by J. H. Sullivan, Trustee for Mrs. Lizzie S. Garlington, by deed dated November 28, 1911, recorded in Book 32, page 143, and by the Reedy River Power Company conveyed to the National Utilities Company of South Carolina by deed dated February 15, 1928, recorded in Book 57, page 29.

Also, those rights, privileges, and easements granted to N. B. Dial and others by J. H. Sullivan, Trustee for Mrs. Lizzie Garlington, by deed dated October 3, 1904, recorded in Book 31, page 336, and by deed dated March 7, 1905, recorded in Book 9, page 566, and by N. B. Dial and others granted to the National Utilities Company of South Carolina by deed dated March 1, 1928, recorded in Book 57, page 128.

The properties hereinbefore described under Items 4 to 22, both inclusive, are the lands and water rights which constitute the Hydro-Electric Development of the part of the first part, formerly of the Reedy River Power Company, known as the Boyd's Mill Plant.

23. That tract of land containing 73 Acres, more or less, known as the Tumbling Shoals Mill Place, lying on both sides of Reedy River but mostly on the West side of said Reedy River, bounded on the North by Horse Creek, on the East by lands of W. D. Sullivan, on the South by lands formerly owned by Joseph Poole, later by Dan Beeks, and on the West by lands, formerly owned by Keziah J. McCullough, as shown by plat thereof made by John M. Hudgens, Surveyor.

Also, the right to flood, by backing water in, over, upon, and through the same, any other lands adjoining or adjacent to the above described tract of land and owned by Wm. D. Sullivan on October 21, 1911, by reason of the erection, construction, and maintenance of a dam or dams by the Sullivan Power Company, its successors or assigns, at or near the said Tumbling Shoals.

The above described tract of land and water rights are the same which were granted to the Sullivan Power Company by Wm. D. Sullivan by deed dated October 21, 1911, recorded in Book 32, page 113, and by the Sullivan Power Company to the National Utilities Company of South Carolina by deed dated February 15, 1928, recorded in Book 57, page 27.

24. That tract of land on Reedy River and Horse Creek, above Tumbling Shoals, containing 6.40 acres, more or less, bounded by the lands of R. E. Taylor and the lands formerly of Sullivan Power Company and others.

Also, the right to back water on the adjoining property owned by R. E. Taylor on July 22, 1915, from the dam at Tumbling Shoals.

The above described land and water right are the same which were granted and conveyed to the Sullivan Power Company by R. E. Taylor by deed dated July 22, 1915, recorded in Book 37, page 135, and by the Sullivan Power Company conveyed to the National Utilities Company of South Carolina by deed dated February 15, 1928, recorded in Book 57, page 27.
