Beginning at an iron pin on Cannon Street, at the northwestern corner of lot numbered one (1), and running thence with said Cannon Street, N. 5-30 W. one hundred (100) feet, to an iron pin, the south-western corner of lot numbered three (3); thence along the line of lot numbered three (3), N. 74-25 E. one hundred and ninety-six and seven tenths (196.7) feet to an iron pin, the southeastern corner of lot numbered three (3); thence S. 20-45 W. seventy-nine and four tenths (79.4) feet to an iron pin, the northeastern corner of lot numbered one (1); thence along the line of lot numbered one (1), S. 69-25 E. two hundred and twenty four (224) feet, to the beginning corner of Cannon Street, reference being hereby had to said plat.

Lot Numbered three (3)

Beginning at an iron pin on Cannon Street, at the northwestern corner of lot numbered two (2), and running thence with said Cannon Street, N. 3-15 W. sixty-three (63) feet to an iron pin on an unnamed street; thence with said Street, N. 66-35 E. one hundred and sixty-eight (168) feet to an iron pin; corner of lot numbered four (4); thence with line of lot numbered four (4) S. 28-15 E. eighty-five and four tenths (85.4) feet, to an iron pin, the northeastern corner of lot numbered two (2); thence along the line of lot numbered two (2), S. 74-25 W. one hundred and ninety six and seven tenths (196.7) feet to the beginning corner on Cannon Street, reference being hereby had to said plat which is hereto attached and made a part hereof.
