

## TITLE TO REAL ESTATE

KNOW ALL MEN BY THESE PRESENTS, That

and mortgage indebtedness of \$1,000 (not assumed)  
to me paid by *Anna M. Beatty*.in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *Anna M. Beatty*all that piece, parcel or lot of land in *Greenville*, Township, Greenville County, State of South Carolina,

in the City of Greenville, on the south side of Nichols Street, near the B. & O. Railway, containing 29/100 of an acre, more or less, having the following metes and bounds: Beginning at a stone on south side by Nichols Street, A. B. Davis corner and running thence S. 26 $\frac{3}{4}$  W. 24 $\frac{1}{2}$  26 feet to stone; thence S. 63 $\frac{1}{2}$  W. 53 feet to stake; thence N. 26 $\frac{3}{4}$  E. 229 feet to stake on Nichols Street; thence with Nichols Street N. 78 $\frac{1}{4}$  W. 56 feet to the beginning corner, bounded on north by Nichols Street and on south, east and west by lands of A. B. Davis. The above distances are from the deed of Charles A. Parkins to Joseph Harris dated September 27, 1881, recorded in book 11.M., page 150. The city block book page 86, shows the lot to have a frontage of 65 feet and it is the intention of this deed to convey the entire lot, whatever it is.

on the 15th day of March 1880, deed recorded in office of Register  
of Mesne Conveyance for Greenville County, in Book 11.M., Page 150.

Beatty*, *her* heirs and assigns, against *myself* and *my* heirs, and every other person whomsoever lawfully claiming, or to claim, the same, or any part thereof.
