## TITLE TO REAL ESTATE

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ilda Helton, her heirs and assigns, all my right, title and interest, and to the same being at one time undivided, future to all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in and to

known and designated as lots nos 9 and 10, as shown on a plat recorded in Plat Book G, page 134, and situate on the south side of Hill Top Avenue, near the City of Greenville, County of Greenville, State of South Carolina and more particularly described as follows:

Lot no 9: Beginning at a point on said Avenue 50 feet west of Edwards Street and running thence along said Street N 68 W, 50 feet to lot no 8; thence S 13° 05' W 143.5 feet; thence S 65° 36' E, 50 feet to lot no 10; thence N 13° 05' E 145.6 feet to the beginning corner.

Lot no 10: Beginning on said Avenue at Edwards Street, and running thence N 68° 00' W 50 feet to lot no 9, thence S 13° 05' W 145.6 feet; thence S 65° 36' E, 60 feet to Edwards Street; thence along said Street N 9° 49' E, 100 feet to the beginning corner.

It is understood that this conveyance is made subject to all existing leases, which said leases the grantee herein does not assume payments.
