All that certain piece, parcel or lot of land situated, lying and being in Greenville Township, Greenville County, State of South Carolina, being known and designated as lot #1 of the Eliza T. Looper property as shown on plat made by R. E. Dalton, Dec. 1934, and described as follows, to-wit:

Beginning at corner of Looper and Gordon Streets and running thence with Gordon Street S. 71-17 W. 51.5 feet to corner of lot #2; thence with line of lot #2, N. 16,08 W. 149.8 feet to a point in line of lot #39; thence with line of lot #39, N. 71-17 E. 69.4 feet to Looper Street; thence with Looper Street S. 9-18 E. 151.8 feet to the beginning corner.
