In the town of West Greenville, on the south side of Pendleton Street, known and designated as part of lots Nos. 17 and 18 on plat of lands of Melville Land Company recorded in R. M. C. Office for said County in Plat Book A, page 97, having the following courses and distances: Beginning at an iron pin, corner of Lot No. 8 as shown on said plat and running thence with line of said lot S. 43-45 W. 130.7 feet to iron pin, corner of Lots 8 and 9; thence continuing in the same courses as the dividing line between lots 8 and 9 in a westerly direction 100 feet to stake in line of lot 19; where grantor resides; thence with line of said lot N. 43-45 E. 86.6 feet to iron pin on Pendleton Street, and thence with Pendleton Street S. 64-30 E. 107.11 feet to beginning.
