all that place, parcel or lot of land in Greenville, Greenville County, State of South Carolina, situate, lying and being on the north side of West Earle Street in the City of Greenville being known and designated as Lot "F" of Block 6 on plat of Mountain City Land and Improvement Company, recorded in the R. M. C. Office for Greenville County in Deed Book "A" page 60, and having the following lines and boundaries to wit:

Beginning at a stake on the north side of West Earle Street at corner of Lot "F"; and running thence with the line of said lot N. 54° 2' 20" E. 200 feet to a stake thence N. 34° 2' 20" E. 65 feet to corner of Lot "H", the one with the line of said lot S. 52° W. 200 feet to West Earle Street, thence with line of said street S. 84° 2' 20" E. 65 feet to the beginning corner bearing the same.
